\* In recognition of a Member's long years of loyal CCC membership, after completing 20 years of Membership, AND upon reaching an age of 75 years of age by January 1 for any upcoming Club Season, the annual dues may be reduced by 50% of that Member's regular dues (50% of the individual, or family, or Non-resident dues amount). This same 50% reduction will be offered to any Trustee upon completion of 12 years as a Club Trustee, AND upon reaching 65 years of age by January 1 of any Club Season. To eliminate the appearance that this Trustee portion of the proposal is intended for the immediate benefit of any qualifying Trustees, the Trustee provision shall not be applied to any serving Trustees until the start of the 2019 Club Season.

Dear Club Member,

Our insurance carrier requires that we secure a Release/Waiver from all members. This is primarily for the purpose of eliminating any type of "nuisance" suit activity that might be filed against the Club. This does not relieve the Club of its normal responsibilities to operate the club safely. This type of Waiver is common with most Clubs. We also incorporate Release language allowing photos of Members to be used solely for newspaper articles / press releases relating to the Club.

### **RELEASE AND WAIVER**

I/We certify that I/We am healthy and have no physical or mental disabilities or infirmities that would restrict full participation in any of these activities.

I/We therefore waive, release and hold harmless the Club, its Trustees, Officers and others acting on behalf of the Club from any and all responsibility or liability for any injury or damage to myself.

I/We agree that prior to me or my invited guest's participating in any activity occurring in or about the Club's facilities, I/We will attempt to note by direct examination and observation any existing unsafe conditions at the club that may result in possible injury. I/We will refrain from using such facilities if, in my judgment, such conditions exist. I/We will also notify the management of the Club of any unsafe conditions noted by me that do exist, so that proper corrective action, if possible, can be taken.
